Theme

Market power, defined as the ability of a firm (or group of firms) to set and maintain price above (or below, for inputs) the level that would prevail under competition, has been a key concept in supply chain analysis and market organization studies for decades. Yet, recent studies questioned the ability of the market power framework to predict economic behaviour in the agri-food system, and new theories and extended models are being developed to explain empirical evidence. The seminar considers this new literature and explores the implications of the emerging characteristics of the agri-food supply chains for scholars, policy makers and the industry.

Objectives

The goal of the seminar is to present new ideas and contributions on the topic of market and bargaining power and its implication for the food supply chain. The seminar will bring together agricultural and applied economists, policy makers and industry representatives to discuss the theoretical, empirical and regulatory implications of the new dimensions in power and bargaining. Multidisciplinary contributions with special emphasis on law and regulation are also welcome.

Seminar tracks

Track 1: Competition and bargaining power covers theoretical and empirical issues related to the various dimensions of power and bargaining. Contribution may address: distribution and redistribution of bargaining power, estimation of market/bargaining power, analysis of business practices, competition effects of private labels, competition models, price transmission, pricing strategies and industrial organization studies in general.

Track 2: Contracts and collective action considers the implications of the distribution of bargaining power on the governance of the supply chains. Discussion topics cover: i) negotiation, contracting, use of standards, and conflict management in the supply chain, ii) countervailing power, agricultural cooperatives, and producer organizations, iii) bargaining power and coordination: hybrid firms, networks, business partnerships, iv) bargaining power and asymmetric information, v) implications for sustainability and corporate social responsibility vi) studies about the economics of organization.

Track 3: Regulation covers topics concerning the interaction between public intervention and the exertion of bargaining power by private agents, including: regulation to limit bargaining power, optimal regulation under imperfect competition, legal framework for competition policies in agriculture, competition and agricultural policies and the EU.

Track 4: Agri-food SME and bargaining power. explores the impact of bargaining power on agri-food SMEs and their strategies to deal with high concentrations of power. Topics may include: strategies to avoid dependency, adaptation strategies, direct and alternative marketing channels, alternative food networks, informal and local markets, SME innovation and diversification.
