Background:

The NRRP Project ONFOODS "Research and innovation network on food and nutrition Sustainability, Safety and Security" - Working ON Foods is funded within the framework of the National Recovery and Resilience Plan (NRP) under the Next Generation EU programme. The project is part of one of the 14 Extended Partnerships under the NRRP and focuses on the thematic area 'Models for Sustainable Food'. ONFOODS is coordinated by the University of Parma and sees the collaboration of 26 institutions involved in the food and nutrition sector, including university and research institutes in Italy, with food industries and co-operative societies (www.onfoods.it).

The objectives of the ONFOODS Project:

The Project started in November 2022 and over three years aims to pursue six main objectives: 1 Promote sustainability of food production; 2. Increase adherence to more sustainable dietary patterns; 3. Promote sustainability of food distribution; 4. Improve the quality of food and diets; 5. Develop innovative smart technologies for sustainable food production and consumption; 6. Ensure food security and adequate access to food for the entire population and vulnerable groups

Preferred research topics

The workshop aims to promote the comparison between researchers with respect to the methodologies used and current research in the assessment of the sustainability of food systems that characterise the Italian food system through the discussion of the following topics:

- Accounting and reporting systems for the sustainability of food systems
- Food environments for analysing consumption patterns
- Food distribution and local food systems
- Legal models for alternative and sustainable food supply chains
- Legal instruments for sustainable food labelling
- Quality and sustainable consumption patterns

- Sustainability and alternative food networks
- Sustainability and efficiency of agricultural markets
- Sustainable consumption models
- Sustainable governance models
- Technology transfer and good practices to increase sustainability along food supply chains
- Analysing the impact of food policies
- The food distribution system to reduce waste and develop sustainable markets
- The perception of innovations to increase the sustainability of food systems
- The role of procurement for rural areas
- Legislative challenges regarding the definition and regulation of food sustainability in food supply chains
- Regulatory and policy solutions adopted at national and supranational level to promote a sustainable food chain and sustainable consumer choices
